## Regulations

## 15<sup>th</sup> International Grouse Symposium

### PART 1: DEFINITIONS

1.1 In these regulations of the 15th International Grouse Symposium, hereinafter referred to as the "Regulations", the following terms shall be understood as:
1.1.1 Symposium means the 15th International Grouse Symposium 2023 organized on September 11-15, 2023 on the campus of the University of Bialystok at ul. J. Ciołkowskiego 1, by the University of Białystok, in cooperation with the Regional Directorate of State Forests in Białystok and the Polish Academy of Sciences.
1.1.2 Organizer the organizer of the Symposium is the University of Białystok with

1.1.3. **Conference Participant** - a person with full legal capacity, as well as a legal person or an organizational unit without legal personality, which the law grants legal capacity, which concluded an Agreement with the Organizer to register in the Form and the Benefits Panel on the terms set out in these regulations.

**1.1.4. Symposium Website** - symposium website with all relevant and current information about the Symposium: https://igs2022.uwb.edu.pl/pl/home/, i.e. the Symposium program, plenary speakers, important dates, workshops, conference committee, field trips, post-conference trips, registration costs, abstracts, location, accommodation options, contact with the Organizer and other information necessary for the proper organization of the Symposium

1.1.5. Registration form – available on the website at:

https://igs2022.uwb.edu.pl/pl/rejestracja/ and enables the participant to register for the Symposium and select benefits in accordance with the rules set out in these Regulations. 1.1.6 **Benefits Panel/Payment Panel** is available on the website https://igs2022.uwb.edu.pl/pl/rejestracja/ and enables the Participant to select benefits and make online payments for selected benefit options.

1.1.8 **Newsletter -** a service provided by the Organizer by sending information regarding the Symposium in the form of messages (e-mails) via e-mail to the e-mail address provided by the Participant.

#### SECTION 2: GENERAL PROVISIONS

2.1 The Regulations define the rules for the provision by the Organizer to Participants of electronic services consisting in enabling Participants to register via the Internet via the website to participate in the Symposium and to select the services proposed during the symposium in the benefits panel / payment panel.

2.2 The costs of benefits specified in the Benefit Panel/Payment Panel are expressed in PLN and are gross amounts. The organizer may modify the services and their prices. However, these changes do not affect the individual benefits already selected and paid by the participant.

2.3 The Participant's selection of benefits in the Benefits/Payment Panel is possible after prior registration by the Participant via the Registration Form on the website.2.4 The registration procedure is described in part 3 of these Regulations.

2.5 To use the registration form, it is not necessary to have specific technical conditions by a computer or other devices (e.g. smartphone or tablet). All you need is Internet access, a working e-mail address, a standard operating system (e.g. Windows, MacOS) and a web browser.

2.6 For the correct use of the Website, it is required to enable cookies in the web browser. It is then possible to delete them through the appropriate options available in the web browser or other software. Detailed information on cookies is available at https://igs2022.uwb.edu.pl/pl/home/.

2.7 The Organizer informs that the Participant may contact the Organizer:

#### PART 3: PARTICIPANT REGISTRATION

3.1 The Symposium may be registered by persons with full legal capacity, legal persons or organizational units without legal personality, to whom the law grants legal capacity.

3.2 To register, go to the Website in the "ORGANIZERS" tab located in the upper part of each of the subpages that make up the Website, and then the "REGISTRATION" link. There is a registration form that the participant fills in by entering the data and ticking the single or multiple selection boxes.

3.3 The form should be filled in with the true data required for correct registration: First name, Surname (Last name), Academic degree, Institution, address, telephone contact, e-mail, speech, poster, declaration of participation in paid additional activities (multiple-choice box), special food requirements. If you need to issue an invoice, please provide the invoice data: company name, tax identification number, business address.

3.4 The e-mail address provided in the form will be used for correspondence between the Organizer's representative and the Participant.

3.5 It is forbidden to add illigal or untrue content in the form, in particular personal data of third parties who have not authorized registration on their behalf.

3.6 By clicking the "Register" button, the registration form is submitted.

3.8 Participant registration is required to select and use the benefits specified in the Benefits Panel/Payment Panel.

3.9 Activities related to participant registration and selection and online payment for services are free of charge for the participant. The organizer bears the costs related to the online payment and the costs of currency conversion of the payment if it is made in a foreign currency.

3.10 In case of resignation from participation in the Symposium, the Participant will receive a refund of the funds paid for services at the Symposium only if he submits his resignation to the Organizer by July 31, 2023. The resignation notification should be sent by July 31, 2023 to the e-mail address: igs2022@uwb.edu.pl.

3.11. The refund to the Participant will be reduced by the costs incurred by the Organizer related to online payments using the e-commerce platform and the costs related to currency conversion in the case of international transfers.

3.12. It is possible to register another participant in place of a previously registered participant with paid benefits. In this case, the data of such a person should be submitted by September 8, 2023 to the e-mail address: igs2022@uwb.edu.pl.

3.14. The Participant selects the method of payment for the services indicated in the Benefits Panel/Payment Panel:

3.14.1 Online payment (payment card on the e-commerce platform) by clicking the "PAY" button after summarizing the benefits in the Benefits Panel/Payment Panel.3.14.2 on the basis of prepayment to the account (transfer to the account) on the basis of a Proforma Invoice issued by the Organizer and sent electronically (e-mail) to the Participant.

3.15. The costs related to the payment are paid by the Organiser.

3.16 The costs related to the refund of payments by the Organizer to the Participant shall be paid by the Participant.

3.17. At the request of the Participant, the Organizer issues an invoice in accordance with applicable law in Poland and the European Union. The invoice is delivered to the Participant in PDF format in the e-mail indicated in the registration form by the participant or in a paper form.

3.18. If the benefits are not paid within the time limits and amounts specified on the website in the Conference Costs, the Participant's registration will be canceled or the Participant will not be able to use the specified benefits during the Symposium.

3.19 Successful registration at the Symposium requires acceptance of the Regulations and the Policy. Consent to sending the Newsletter is voluntary and is not necessary for effective registration.

# PART 4: IMPORTANT DATES AND COSTS OF THE SYMPOSIUM

4.1. Costs of participation in the SYMPOSIUM and the scope of services: 4.1. The registration fee includes the costs of organizing the conference, lunch during the conference and field trip, conference materials and participation in field trips. 4.2. The registration fee does not include the costs of: participation in workshops, breakfast and dinner, banquet, accommodation, post-conference trips 4.3. Benefits under the Symposium are as follows: PLN 800.00 – regsitration fee when registering until June 30, 2023 PLN 1,000.00 – registration fee when registering until August 30, 2023 PLN 400.00 - reduced registration fee when registering until June 30, 2023 (applies to students, PhD students, other persons) PLN 500.00 – reduced registration fee when registering until August 30, 2023 (applies to students, PhD students, other persons) PLN 300.00 – cost of participation in the conference banquet (on September 12, 2023) PLN 500.00 – the cost of a trip to the Białowieża National Park or PLN 400.00 - the cost of a trip to the Biebrza National Park - on September 16, 2023 PLN 400.00 - the cost of participation in the workshop on September 11, 2023 regular price PLN 200.00 - cost of participation in workshops on September 11, 2023 - discount for students 4.4. Participants from Ukraine are free of charge. 4.5. Important dates specified on the Symposium Website:

01.05.2023 - sending proposals for workshops to be implemented during the symposium

31.05.2023 - submission of abstracts of speeches and posters

30.06.2023 - acceptance of speeches and posters

30.06.2023 - registration of participants at a reduced amount

(PLN 800 regular, PLN 400 reduced)

31.07.2023 - participant's resignation date (full refund), no refund after this date

31.08.2023 - registration of participants is completed (registration cost PLN 1,000 normal, PLN 500 reduced).

4.6. The costs of services selected in the Benefits Panel/Payment Panel should be added to the entry fee and paid according to the rules set out in point 3.14.

4.7. The participant provides transport to the Symposium and accommodation during the symposium on his own.

### PART 5: FINAL PROVISIONS

5.1 The Regulations are available on the website and at the Organiser's registered office

5.2 The Seller reserves the right to change these Regulations for important reasons, such as:
